Offers received after the closing date will not be accepted.

Peace Corps will evaluate all quotations received by the deadline based on the minimum requirements and/or evaluation factor(s) shown below. Contingent on the availability of funds and continued need for the supplies and/or services, at the end of the evaluation process, Peace Corps intends to award a firm-fixed-price contract for the purchase of the required supplies and/or services to the selected vendor.

Peace Corps may include option periods up to 4 years in the awarded contract.

Supplier Unit Quotes shall be a Firm Fixed-Price, and inclusive of any administrative or overhead costs. Peace Corps is VAT exempt. VAT-exemption documentation will be provided along with contract after selection is made.

B. Statement of Work/Description of Requirements

Vendor(s) may be requested to furnish fuel, postpaid fuel cards, and vehicle fuel security and monitoring provisions for Peace Corps/Kenya in accordance with the terms established under the contract. Vendor(s) will be expected to fulfill orders placed under the agreement according to the estimated quantities detailed above.

The purchase price for items purchased under this agreement shall be the prices submitted in response to this quotation. In the event that the Government of Kenya raises or lowers the fuel price in Kenya, the contract established will be modified to reflect the new prices. Proper documentation of the increased fuel price must accompany the modifications.

The following security provisions should also be included at a minimum:

- 1) Individual Driver Pin codes
- 2) Vehicle credit cards with pin codes
- 3) Security label on vehicles to ensure only authorized vehicles are fueled
- 4) Security feature which requires mileage to be entered at time of purchase
- 5) Monthly statements which include vehicle, driver, quantity of fuel, station, mileage entered, etc.
- 6) Online daily access to fueling data
- 7) Email and/or SMS alerts for irregular fueling
- 8) A control process to prevent fraudulent transactions in the event of a lost or stolen card

D. Delivery Schedule

Preferred station locations are located in counties throughout Western Kenya, though service needs are not limited to these locations and service stations should be available throughout all of Kenya.

Schedule: Fueling must be available 24 hours/day, 7 days/week.

Delivery Location: Fueling stations located across Kenya.

E. Contract Terms and Conditions

As an Agency of the United States Government, Peace Corps has an approved contract template that it intends to use for the award. Peace Corps reserves the right to deny making a contract award to a vendor should they refuse to sign the Peace Corps approved contract template.

F. Minimum Criteria:

A quotation will not be considered further if it does not meet the following minimum criteria:

- Conformance to Statement of Work/Description of Requirements
- Delivery schedule
- Delivery locations
- Timeline.

G. Contract Terms and Conditions

Payment will be made 30 days after completion of services or as agreed upon in contract negotiations. Favorable payment terms will be considered in the evaluation factors.

Please provide name of a CONTACT PERSON. This will be the liaison person between the vendor and Peace Corps during this procurement.

H. Peace Corps Payment Schedule and Terms

Supplier will receive payment in approximately 30 days after acceptance and receipt of valid/accurate invoice.

I. Evaluation Factors:

Quotations that meet the minimum criteria listed above may be further evaluated based on the following factors:

- Price
- Payment Terms
- Past Performance/Reference Checks
- Other Security and fraud prevention measures; number and location of participating stations

Award may be made with or without negotiations between the Peace Corps and the selected vendor. Award may be made to other than the lowest-priced quote. The award will be made to the total quote that offers the best value in accordance with the above evaluation factors.

All vendors that submit quotations in response to this RFQ will be notified of the results.

J. Instructions to Vendors:

- a. Please read RFQ in its entirety including factors that will be considered in making award.
- b. Return completed RFQ by due date as follows:
 - 1) Fill in prices in Attachment A.
 - 2) Unless delivery date(s) are provided, provide delivery date(s) in Section D.
 - 3) List/state any other terms or items in Section I not requested in the RFQ that is believed would benefit Peace Corps and would improve consideration for selection. These terms/items must not increase the prices quoted in Section A. This should include payment terms, warranty provision, and at least three traceable references for works completed of similar nature.
 - 4) Sign and return RFQ by required due date.
